



2018 LABOR DAY SAFETY AND OPERATIONAL PAUSE



The 2018 Labor Day Safety and Operational Pause is directed by the Commanding General, MCIEAST in message CG MCIEAST-MCB CAMLEJ R 031830Z AUG 18. The 2018 Labor Day Safety and Operational Pause will be conducted from 17-28 September 2018. Supervisors are required to lead their Civilian Marines through completion of the five tasks listed below. The training must be completed NLT 1200, Wednesday, 26 September 2018. After the training is completed, supervisors should submit this worksheet to their respective Division Training Coordinator for input into ESAMS (Course # 6204).

Task 1: CY18 Command Safety Program Goal #1

In support of the CY18 Command Safety Program Goal #1, supervisors will review with their employees, the JHAs for their areas to ensure hand hazards are identified and assessed for engineering controls and the specific type of glove is identified for the task.

Task 2: Hand Safety Training (Optional)

Task 3: CY18 Command Safety Program Goal #2

In support of the CY18 Command Safety Program Goal #2, supervisors will record sign deficiencies (missing, unnecessary, faded, non compliant) and present this information to their division safety officer. Division safety officers will add valid sign deficiencies to their hazard abatement log and request the appropriate signage from the Risk Management staff.

Task 4: VPP Frequently Asked Questions (FAQ's)

Supervisors will lead a question and answer session with their employees in order to re-familiarize them with the VPP FAQ's. The FAQ's are in any of the previously published VPP Passports and on the Risk Management website.
